Should the force majeure situation persist for a prolonged period, both parties retain the right to negotiate the termination or modification of the agreement, if necessary, based on mutual understanding and in accordance with the governing laws of Cyprus.

Governing law

These Terms and Conditions shall be governed by and construed in accordance with the laws of Cyprus. This means that any legal issues or disputes related to these Terms will be governed by the laws of Cyprus. Both parties agree that any dispute arising out of or related to these Terms will be subject to the non-exclusive jurisdiction of the courts of Cyprus. This allows disputes to be resolved in Cyprus, but does not preclude the possibility for the parties to seek resolution elsewhere.

Legal Jurisdiction
